

# California Codes & Restrictions

Type Of Carry Allowed: Concealed

Carry In Restaurants That Sell Alcohol For Consumption: Yes

Not in Bars or Taverns that receive the majority of revenue from selling alcohol.

Note: If your California License has a restriction about carrying in establishments that sell alcohol, you cannot carry there. There is no state law covering this provision.

## Locations where carry is restricted

- Penal Code 27330. No person at a gun show or event, other than security personnel or sworn peace officers, shall possess at the same time both a firearm and ammunition that is designed to be fired in the firearm.
- Penal Code 171c(a)(1) Any person who brings a loaded firearm into, or possesses a loaded firearm within, the State Capitol, any legislative office, any office of the Governor or other constitutional officer, or any hearing room in which any committee of the Senate or Assembly is conducting a hearing, or upon the grounds of the State Capitol, which is bounded by 10th, L, 15th, and N Streets in the City of Sacramento .
- Penal Code 171b(b)(2)(B) Notwithstanding subparagraph (A), subdivision (a) shall apply to any person who brings or possesses any weapon specified therein within any courtroom if he or she is a party to an action pending before the court.

While exercising the privileges granted to the licensee under the terms of this license, the licensee shall not, when carrying a concealed weapon:

- Consume any alcoholic beverage.

- Be in a place having a primary purpose of dispensing alcoholic beverages for on-site consumption.
- Be under the influence of any medication or drug, whether prescribed or not.
- Refuse to show the license or surrender the concealed weapon to any peace officer upon demand.
- Impede any peace officer in the performance of his/her duties.
- Present himself/herself as a peace officer to any person unless he/she is, in fact, a peace officer as defined by California law.
- Unjustifiably display a concealed weapon.
- Carry a concealed weapon not listed on the permit
- Carry a concealed weapon at times or circumstances other than those specified in the permit.

PC 26200: (a) A license issued pursuant to this article may include any reasonable restrictions or conditions that the issuing authority deems warranted, including restrictions as to the time, place, manner, and circumstances under which the licensee may carry a pistol, revolver, or other firearm capable of being concealed upon the person.

(b) Any restrictions imposed pursuant to subdivision (a) shall be indicated on any license issued.

### PENAL CODE SECTION 626-626.11

(4)When the person is exempt from the prohibition against carrying a concealed firearm pursuant to Section 25615, 25625, 25630, or 25645.

NOTE: Be cautious about carrying on any school property. If you have to go into the school to meet with a teacher, or anyone, leave your pistol un-loaded in a car

lock case, in your trunk in a locked gun case, or something that can be securely locked from unauthorized individuals. Be CAUTIOUS.

## **State Parks / Road Side Rest Areas / State Game Areas**

### **Carry Allowed in these Areas:**

- \* State Parks: YES
- \* State/National Forests: YES 14 CCR s 1413
- \* State Game Refuges: NO F/G Code 10500
- \* Road Side Rest Areas: YES *As per California Highway Patrol.*

### **California Deadly Force Law**

## **California Penal Code Section 196-199**

196: Homicide is justifiable when committed by public officers and those acting by their command in their aid and assistance, either

197: Homicide is also justifiable when committed by any person in any of the following cases:

198: A bare fear of the commission of any of the 198.5. Any person using force intended or likely to cause death or great bodily injury within his or her residence .

199: The homicide appearing to be justifiable or excusable, the person indicted must, upon his trial, be fully acquitted and discharged.
